

Pierce Law Review
Publication Agreement

This Publication Agreement (the “Agreement”), dated _____, is between _____ (the “Author”) and the *Pierce Law Review* (the “Law Review”), and governs _____ (the “Article”).

1. The copyright in the Article shall remain with the Author. Nothing in this Agreement should be construed as an assignment of copyright ownership to the Law Review.
2. The Author grants to the Law Review a license to publish, print, reprint, post, and otherwise disseminate the Article in any and all mediums. Specifically, the Author grants to the Law Review (a) an exclusive right of first publication (provided, however, that the Author may post drafts of the Article on SSRN, ExpressO or any other similar means of peer-review distribution so long as the Author notifies the Law Review) and (b) a non-exclusive right of publication thereafter. This non-exclusive license includes the right to authorize the electronic reproduction of the Article by LexisNexis, Westlaw, Hein Online, or any similar electronic database, to authorize others to reproduce the Article for noncommercial or educational purposes, and to transfer or sublicense the rights granted to the Law Review in this agreement.
3. Any reproduction of the Article, including, but not limited to, its publication, posting, or excerpt in print or on the Internet, shall give attribution to the Article’s original publication in the Law Review, using an appropriate method of citation such as:

“Originally published in [Volume] *Pierce L. Rev.* [Start Page] ([Year]).”

4. The Author warrants that:
 - a. The Author has the right to license the Article to the Law Review, and has not made any agreement that would conflict with this Agreement;
 - b. The Article has not previously been published, in whole or in part (provided, however, that the Author may have posted drafts of the Article on SSRN, ExpressO or any other similar means of peer-review distribution so long as the Author notifies the Law Review);
 - c. The Article does not infringe the copyright or property right of another;
 - d. The Article does not contain matter that is defamatory, violates another’s rights of privacy or publicity, or is otherwise unlawful; and
 - e. The Author will indemnify and hold harmless Franklin Pierce Law Center and the Law Review, its licensees and distributes, against any damages, losses, or expenses incurred as a result of the Author’s breach of any of the above warranties.
5. The Author authorizes the Law Review to edit and revise the Article prior to publication, and agrees to respond in reasonable time to edits, page proofs, and any related correspondence. Before the Article is published in the Law Review, the Article must be acceptable to both the Author and the Law Review.
6. The Law Review will provide the Author with three (3) free copies of the bound issue in which the Article appears and fifty (50) free reprints of the Article as per its normal policy. The Author will have the opportunity to order additional reprints at the Author's expense before the issue containing the Article goes to press.
